

TERMS & CONDITIONS OF USE OF THE SKYLounge
ON THE WARSAW-MODLIN AIRPORT

1. The SkyLounge on the Warsaw-Modlin Airport (hereinafter: “**SkyLounge**”) is operated by SKYJET Sp. z o.o. with registered seat in Nowy Dwór Mazowiecki, ul. gen. Wiktora Thommee 1A, entered into the register of entrepreneurs maintained by the District Court for the Capital City of Warsaw in Warsaw, XII Commercial Department of the National Court Register under number 0000351381 (hereinafter: “**Operator**”).
2. The SkyLounge is open seven days a week between 6:00 and 21:30.
3. Entrance and use of the SkyLounge is allowed for all persons who will effectuate an entrance fee payment possess a valid SkyLounge membership card or other card entitling to use the SkyLounge as well as persons who possess a special invitation issued by the Operator.
4. The SkyLounge entrance fee amounts to 69 PLN. Entrance for minors under the age of 3 who accompany their supervisors is free of charge. Entrance fee for minors and youth between the age of 3 to 14 amounts to 49 PLN.
5. Minors and youth up to the age of 18 are allowed to enter and use the SkyLounge solely under the supervision of adults. Passengers and persons using the SkyLounge being supervisors of minors and youth under the age of 18 bear full responsibility for damages inflicted by them or minors and youth under their supervision in the SkyLounge or to other persons in the SkyLounge.
6. Alcohol beverages offered in the SkyLounge are available solely for persons over the age of 18.
7. In case of improper behavior of a minor, who disturbs peace of other guests of the SkyLounge, the personnel shall have the right to ask such person and a minor out of the SkyLounge.
8. All guests being passengers flying out of Warsaw-Modlin Airport should present a boarding pass valid for a flight from Warsaw-Modlin Airport in a given day to the SkyLounge personnel.
9. The Operator shall not be responsible for any consequences of consumption of alcohol offered in the SkyLounge as well as for potential damages inflicted on the Warsaw-Modlin Airport by the SkyLounge guests, particularly after consumption of alcohols offered in the SkyLounge.
10. The duration of stay in the SkyLounge is limited and amounts to 2 hours from the moment of entrance to the SkyLounge. In the event of SkyLounge guest’s improper behavior, the personnel shall be entitled to ask such person out of the SkyLounge before the lapse of 2 hours, without the reimbursement of the SkyLounge entrance fee.
11. In case of eventual complaints caused by, for instance, airport terminal evacuation order, the complaints shall be accepted based on the proof of SkyLounge entrance fee payment.
12. In case of airport terminal evacuation order, a SkyLounge guest shall be entitled to full entrance fee reimbursement, if the guest’s stay in the SkyLounge was not longer than half an hour from the moment of entry. Complaints related to the evacuation should be filed on a form available in the SkyLounge reception, attaching a proof of entrance fee payment and bank account number, to which the payment should be reimbursed. All complaints shall be considered within 3 weeks from the day of filing.
13. All passengers flying out of Warsaw-Modlin Airport who are interested in visiting the SkyLounge are kindly requested to check in and leave their registered luggage at the proper check-in desk before visiting the SkyLounge.
14. The Operator shall not be responsible for any belongings left in the SkyLounge by persons visiting the SkyLounge.
15. Smoking in the SkyLounge as well as bringing luggage trolleys into the SkyLounge is not allowed. The smoking area is located in the airside of the departures hall.
16. All persons visiting the SkyLounge are asked for tolerance and kindness.
